

Understanding Reform/Innovation Dynamics Key Drivers of Innovation/Reform

- Mostly driven by:
 - Budget pressures/crisis (14 countries)
 - Political/government changes (9 countries)
 - Chance events (8 countries)
- Who is in charge of PAR:



 Increasing influence of EC in certain areas (digitalization, administrative burden reduction, one-stop-shops) and regions (CEE, Southern Europe)





Content of Reform/Innovation

- Rather common trends with regard to
 - Open government/transparency (foi, open data, procurement, anticorruption authorities)
 - Civil service reform
 - (cutback/productivity, meritocracy, performance appraisal, code of conduct)
 - eGovernment (portals, signature) and one-stop shops
 - Contrary trends observable: mergers vs. agencification; decentralisation vs. centralization
 - Administrative burden reduction/better regulation and consultation arrangements





Need to continue to address practical actions to **promote trust in** government.




