Ministry for Digital and Economic Affairs



Primary Goals:

- improvement of existing framework conditions to enable digital innovation and technology transfer in the business sector
- coordination and implementation of e-government solutions for citizens, business and industry



Acceleration of Digitization:

- **appropriate strategy** for Austria
- **policy plan for gradual implementation**
- nationwide **coordination and pooling of all IT-resources**

Ministry for Digital and Economic Affairs



Organizational Priorities:

- Federal Ministry for Digital and Economic Affairs as coordinator of digitalisation in Austria
- installation of one Chief-Digital-Officer (CDO) per ministry
- establishment of a digitalisation agency

- **„Mobile first“**: from e-government to m-government
- **„Once Only Principle“**: Implementing the Once Only Principle in Austria

Business Service Portal - Overview



The Austrian Business Service Portal was launched in 2010 as a **one-stop-shop** for businesses (www.usp.gv.at). The portal aims to serve as a single entry point for businesses to public authorities. By offering **information** and **transaction** services, it intends to help businesses to fulfil their legal obligations and to reduce their administrative burdens.

- > The USP focusses on servicing SME's
- > It contributes strongly to the digitization of the communication between SME's and public authorities
- > It acts as an enablers of digitization for SME's

New Strategy for 2023

- > Transformation from a static service platform to a dynamic, bi-directional platform for businesses and authorities.
- > The method:
 - Using a user centric approach, new services are developed and integrated and existing services are reviewed.
 - Iterations in rapid prototyping foster dynamic and adaptability

- All public tenders can be found in one portal, which is free to use

„Relocation“

- Companies will be able to announce the relocation of a site of business online
- Optimized process, that reduces multiple reporting of same information for a company



„Portal Workspace“

- A Dashboard will ensure an efficient and personalized use of the portal
- All relevant services can be accessed via the dashboard



„User Experience“

- Development of a dynamic platform, adaptable to one's needs.
- Modern and intuitive look-and-feel with highest technical standards






