Challenging times - 1



- Many challenges...
 - Economic uncertainty/lack of growth
 - Public finance constraints
 - Security threats (including cyber-security threat)
 - Demographic change
 - Climate change
 - Disruptive technologies
 - Promoting social inclusion
- Happening simultaneously... ("the polycrisis")
- "Perfect storm" Budget constraints and rising/difficult to control demand for services/social benefits





Challenging times – 2



- Greater downside risk from challenges (e.g. climate-related issues)
- Challenge to sustainability of European social model
- Austerity fatigue/challenge of restoring hope (going beyond "weathering the storm"/timescales to address challenges)
- "Permanent Revolution" fatigue
- Setting priorities and the politics of choice
- Need for economic growth to bring fiscal sustainability
- Challenge of risk taking and (sometimes) falling short in innovating
- Adapting to the age of instant/permanent communication and diversity/multiplicity of social media information sources

Challenging times – 3



- The crisis of European/national identity From Brexit to ???
- The rise of political insurgency (anti-state and anti-politics, challenge to "one version of the truth", distrust of "experts")
- Challenge to belief that politics can be a means of social progress and/or the means of issues in citizens' lives
- Challenges to social cohesion
- Reduced confidence/trust in institutions (including government) to meet above challenges





Creative solutions in EPSA 2019 – 1



- Creative responses at all levels of government to the continuing crisis/appropriate to level
- Overarching trends:
 - Actions to enhance trust in government
 - Actions to deepen/broaden social inclusion
 - "From very good to better" no complacency from high performers
 - Cross-government action to identify and manage risk
 - Deepening of stakeholder engagement and co-creation
 - Limited recognition of role of auditors in improving public sector performance and as guardians of probity





Creative solutions in EPSA 2019 – 2



- Trends in EPSA 2019 continued from earlier EPSA editions:
 - Importance of adaptive innovation
 - Measures to promote economic growth
 - Creative approaches to policing
 - Public servants with the energy to volunteer beyond core role
 - Importance of recognising staff as stakeholders
 - Use of shared services/platforms to realise efficiencies
 - Digitalisation of processes





Creative solutions in EPSA 2019 – 3



- Trends in EPSA 2019 not widely observed in earlier EPSA editions or deepened/broadened from them:
 - Systemic approaches to addressing fraud and corruption
 - Use of mobile apps to deliver services
 - Use of big data to support evidence-based policy-making
 - Creation of eco-systems for stakeholder co-creation
 - Integration of UN Sustainable Development Goals into project objectives





EPSA 2019 – Lessons for the future



- Key role of tools such as data visualisation in evidencebased policy-making
- Importance of systemic cross-entity risk assessment and dynamic scenario planning
- Wider use of new decision tools (e.g. hackathons)
- Ensuring data privacy and security by design
- Using time more effectively from processing to judgement
- Digital transformation objective or instrument?
- Wider recognition of the role of auditors as a key element of the process of restoring trust in government
- More effective audit interventions (priorities/timing/scope)





And finally...the lesson of EPSA since 2009



 Innovative policy responses are potentially within the reach of all European public administrations who are open to creating them or ready to follow the example of others who have already succeeded
